Established in 2022, Ignight Capital is a **technology company** focused on promoting the **growth of Digital Ecosystems**.

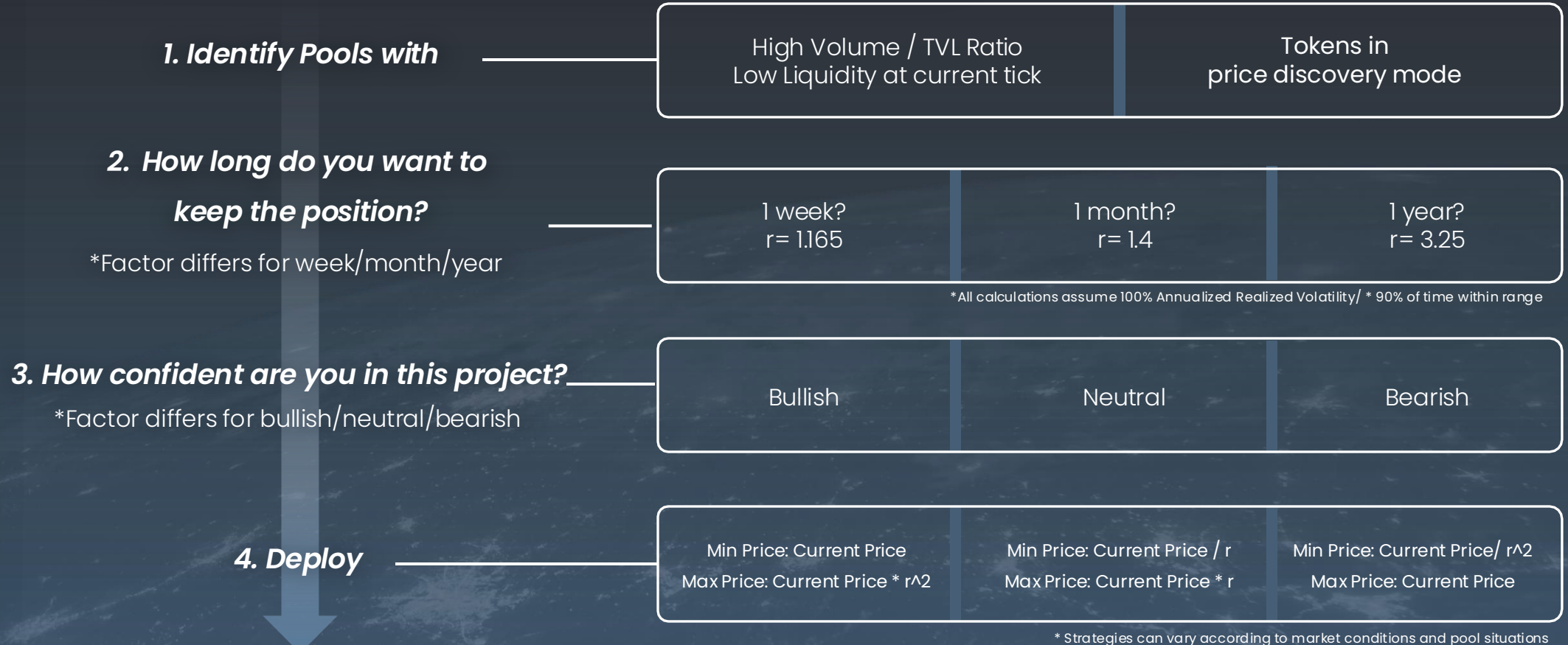

STEP 1: Search and Deploy (Case Example Generalized)

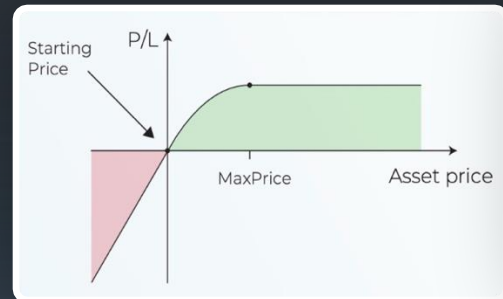

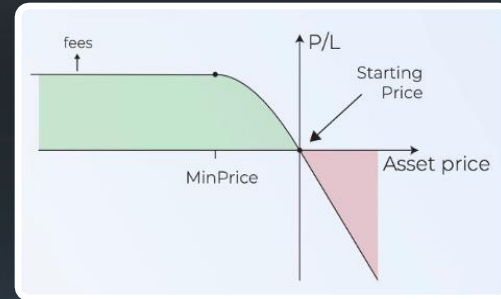
Core Strategy – LP for CAMM

STEP 2: Cope with Market Situation (Generalized)

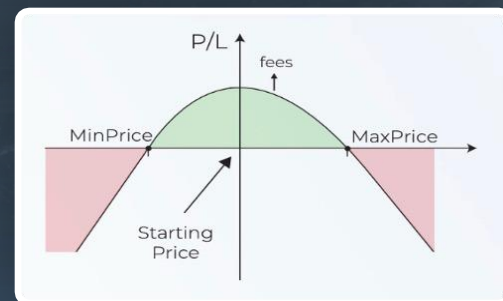
